CARING FOR THE WHOLE PERSON

"Team-Based Care" is the intentional collaboration to center participant experiences through the seamless delivery of holistic services, creating a confident and empowered community where members are engaged and excited. In FY 2023, we expanded the Team-Based Care model across our organization in the areas of residential treatment and transitional and supportive housing. Peer Services play an important part in this model, and every new program we open now includes peer support. We have plans to expand Team-Based Care into our clinics in FY 2024. This means we will be able to more fully meet the individual needs of participants and to creatively collaborate on solutions for treatment options across teams.

INTENSIVE CASE MANAGEMENT

Intensive Case Management (ICM) is a program where mental health professionals provide mental health services, skills training, and resource navigation for individuals in the homes and in the community. In this program, participants are seen often and by an inter-disciplinary team. Individuals served are typically folks experiencing multiple barriers to engaging in traditional mental health services and may be frequent utilizers of hospital level services.

Our ICM team does an excellent job of finding creative solutions to complex needs and works to treat the whole person, rather than a set of symptoms. This year we expanded these services to increase the number of folks served in Multnomah County and started providing these services in Washington County for the first time.



"Without [the Self-Directed Services, or SDS, program] I wouldn't have a place to live. SDS helped me find an apartment. Supported me in figuring out self-care routines and helped me find solutions to problems in my daily life. SDS is giving me the confidence to live independently in the future."

How do we improve the quality of lives versus simply reducing symptoms in adults experiencing severe mental illness? This question drives our decision-making and continues to push us to pursue the best quality of care for as many adults in the Greater Portland area as possible. Working within Multnomah and Washington Counties, we will soon be expanding into Clackamas County with additional services as we explore what is possible with partner agencies and our dedicated team.

We continue to dedicate our time and care to working with participants experiencing severe mental illness (SMI), offering sustainable treatment and long-term care. Everyone deserves to live the life they choose and to find belonging in the community.

OPENING DOORS

In FY 2023, New Narrative welcomed a new 15-unit permanent supportive housing complex: Douglas Fir Apartments. This multi-year project brought together a host of community partnerships. It was made vouchers possible through from the Multnomah County Joint Office of Homeless Services (JOHS) administered through Home Forward. It relies on referrals from CareOregon and the Native American

Rehabilitation Association (NARA), as well as from New Narrative's Intensive Case Management (ICM) Program. Residents have access to on-site clinical and residential support services in a safe environment.

PEER SUPPORT

New Narrative witnessed tremendous impact within its five peer programs in FY 2023.

The new location for our Comfort Zone program opened to great fanfare! Comfort Zone is a lowbarrier community of peers offered in a friendly, safe, non-judgmental space and a place to relax. The space is run by Peer Wellness Specialists with lived experience. The offerings include weekly outings, resource navigation, and peerled groups focusing on the needs of the LGBTQ+, BIPOC, Hearing Voices, Wellbriety Recovery, and Alt2Suicide communities. One of our newest programs Polaris Transition Teams partners with SAMHSA, Oregon Health Authority, and the Washington County Forensic Team to provide peer-based transition support for individuals exiting the Oregon State Hospital (OSH) Community Restoration Services under the "370" designation, which means they are in various stages of determination for fitness for a court trial. This critical mental health work is made possible through funding provided by the Oregon Health Authority through grant-based SAMHSA funds. Referrals began in the Fall of 2022.

WILLIAM'S STORY

William lost his job and his home when his mental health took a turn for the worse. After living on the streets for eight months, an altercation led to his arrest and jail time, followed by a stay at OSH.

With the help of Polaris' Peer Support Specialists, William was able to secure housing and necessities including food, new glasses, and a phone.

He's now employed, living in an apartment, and managing his mental health care.

BUILDING A CULTURE OF FEEDBACK

Every day we are re-imagining what is possible for mental health care in Oregon and beyond. From surveys and listening tours to casual conversation, we take the feedback from staff, participants, and partners seriously, updating programs and treatment options based on best practices and responses to direct experience.

Priscilla Zeuz Trần, a Mental Health Clinician at New Narrative, found opportunities to reimagine the experience for participants.

Priscilla says, "During my time here at New Narrative, I have been able to explore therapy in more creative ways....I think adding elements of representation such as holistic approaches especially including spirituality, cultural humility, and collectivist aspects to our space - has made it a more approachable environment."

They note, "At Mill Park Center I am running a cooking group. I just think about how in my own culture healing is often done over a meal. Together we get to cook food and anyone who comes into our clinic is encouraged to grab some food as well!"

Priscilla's conclusion? "I think there are so many fun things to do with social work to break barriers!" We completely agree.



"I have worked at Luke-Dorf, now New Narrative, for 18+ years now and have seen so much growth in that time. I have always been proud of the compassion, forward thinking and dedication of my coworkers that bring it daily.

COLLABORATION IS KEY

As we build solutions for accessible and sustainable mental health care, we continue to advocate for policies which promote community wellbeing. We pursue and cultivate partnerships with elected officials, agencies and businesses to offer new opportunities with our participants and share resources with providers working for mental health and housing stability.



ADVOCACY FOR OUR COMMUNITY

In FY 2023 our staff and partners advocated for groundbreaking legislation aimed at providing more funding and stability for service providers in Greater Portland and beyond through testifying before legislative committees, writing letters of support, meeting with elected officials, and other activities.



BUILDING CONNECTIONS FOR EMPLOYMENT

We worked with local employers to provide pathways for participants who are interested to pursue meaningful work in the community. Our peer program NorthStar Clubhouse maintains strong relationships to provide connections between employers and participants.

"In 2023, 35% of Ground Up PDX's employee referrals came from NorthStar. They consider the specifics of our business and the skills and readiness of the candidate so that we're setting folks up for success. The advocates at NorthStar are great at determining who from their program would be a good candidate for ours. What I appreciate most about the team at NorthStar is their commitment to supporting staff members through any challenges that may come up while they're working with us. PARTNERSHIPS ACROSS AGENCIES

We partnered with agencies to provide mission-based property management services through our Horizon Property Management operation. We rely on our partner agencies for referrals and to ensure holistic care is continued once participants are housed.


PATRICK'S STORY
